We will make a thorough investigation before we reach any conclusions. We understand this may be a private matter for individuals. For this reason our policy is not to disclose any private information that would identify you. Your name, and location will be kept private. We will make available to the public our evidence that we collect. We feel this evidence must undergo the scrutiny of the paranormal community and the "watchdog" groups. We also understand that some cases the "haunted" status of a site may be desired to be made public. We will make our findings public, when and only when we have received written authorization from the client to do so, and only once we have completed our investigation.

Bluegrass C.S.I. considers applicants without regard to race, color, religion, creed, gender, national origin, age, disability, marital or veteran status, sexual orientation, or any other legally protected status.

This application does not constitute any type of binding contract between Bluegrass C.S.I. and the applicant and should not be construed as such.

The purpose of this application is to provide members of Bluegrass C.S.I. with a better understanding of the applicant's areas of interest. Information on this form will be kept in confidence and will not be viewed by anyone other than Bluegrass C.S.I..
